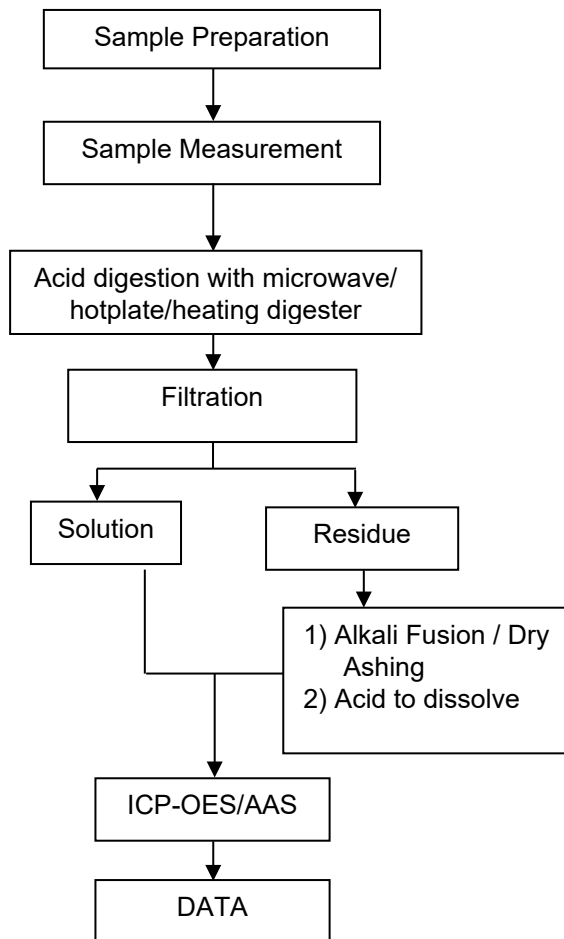

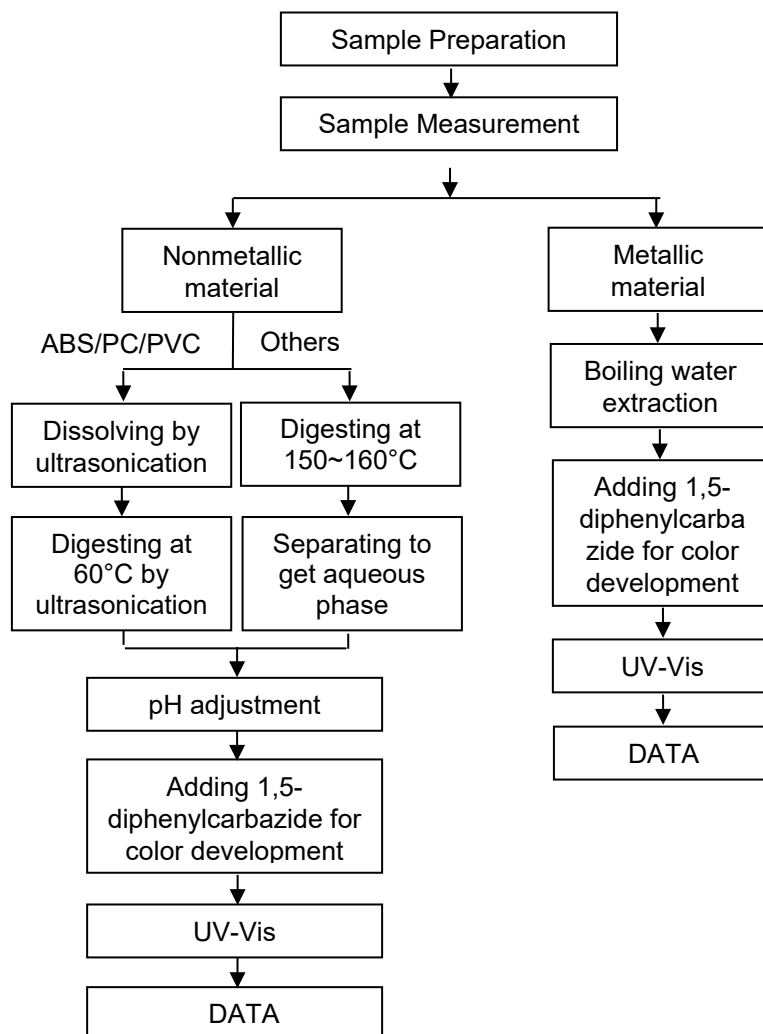

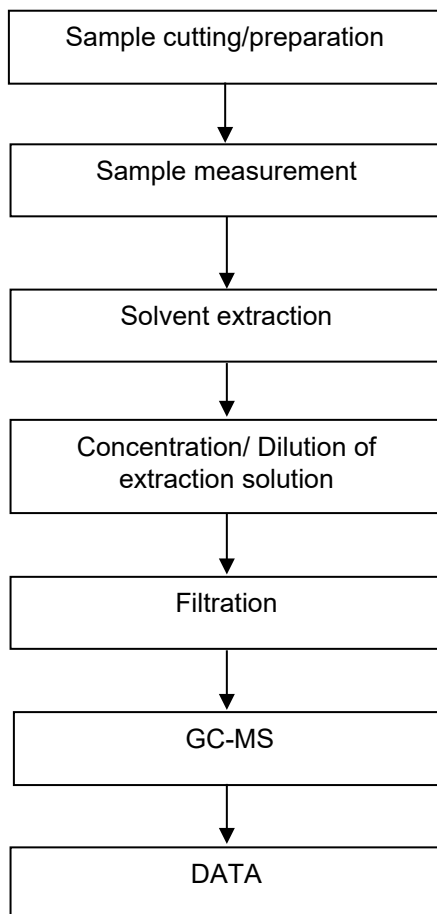

PBB(s)/PBDE(s) Testing Flow Chart



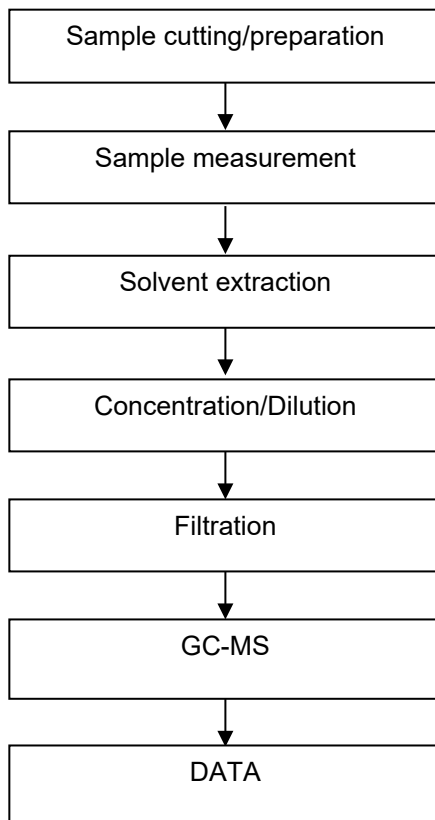

Phthalates Testing Flow Chart



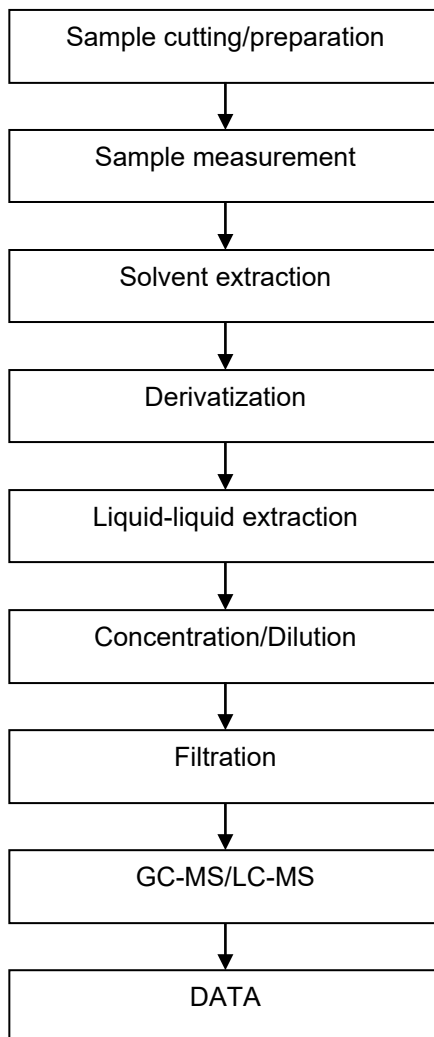

TBBP-A Testing Flow Chart



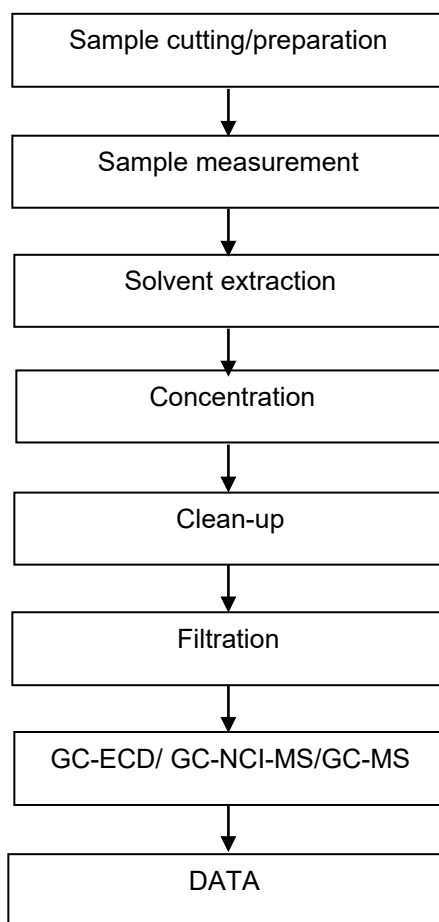

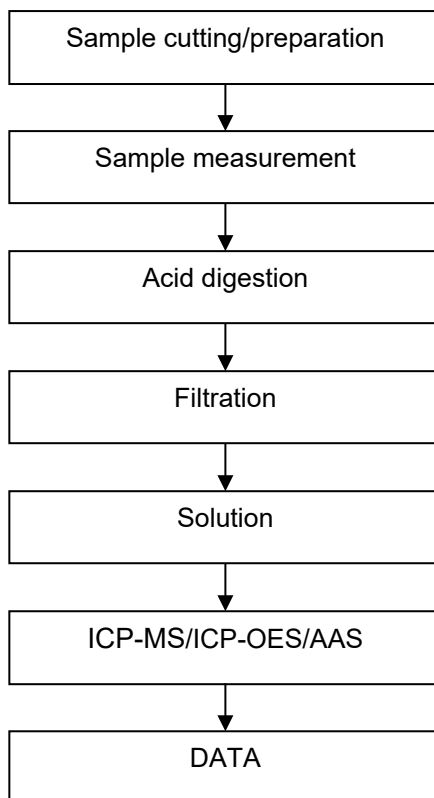

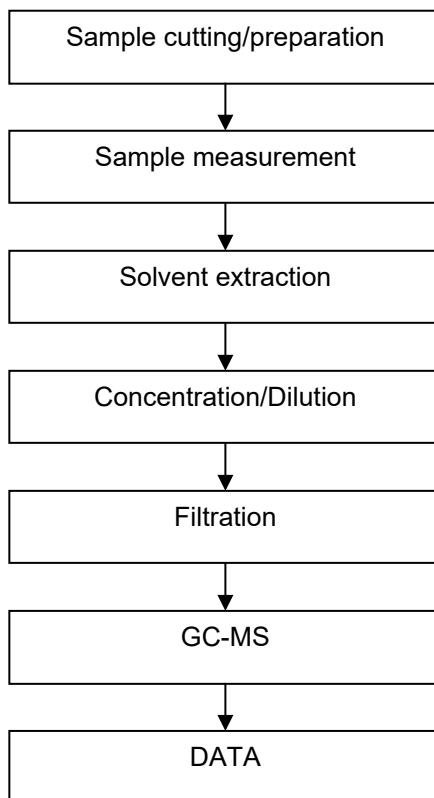

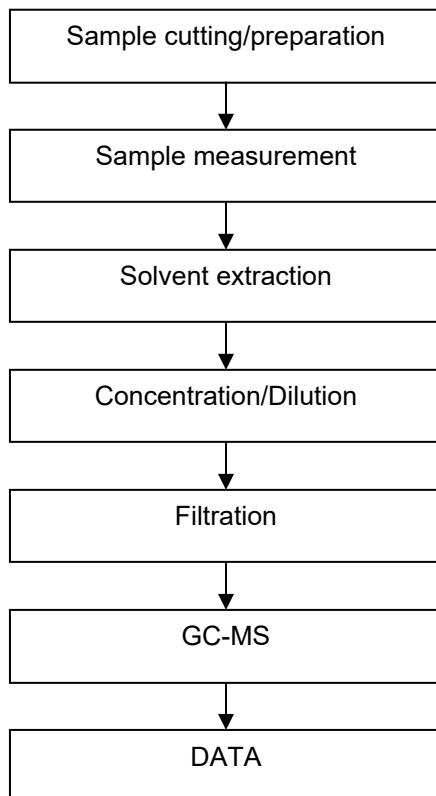

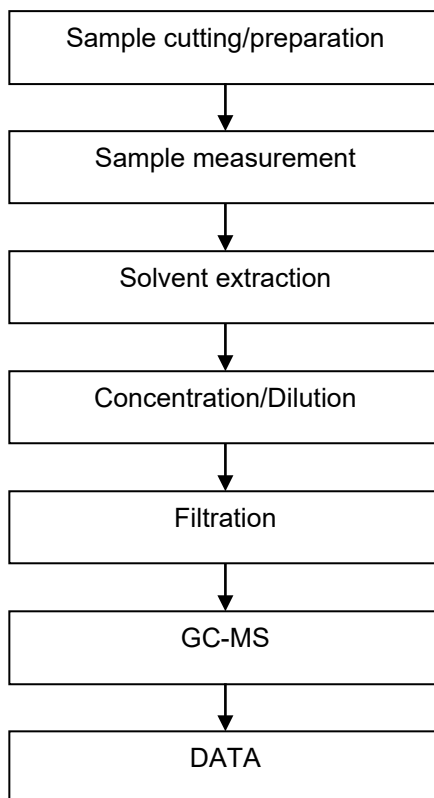

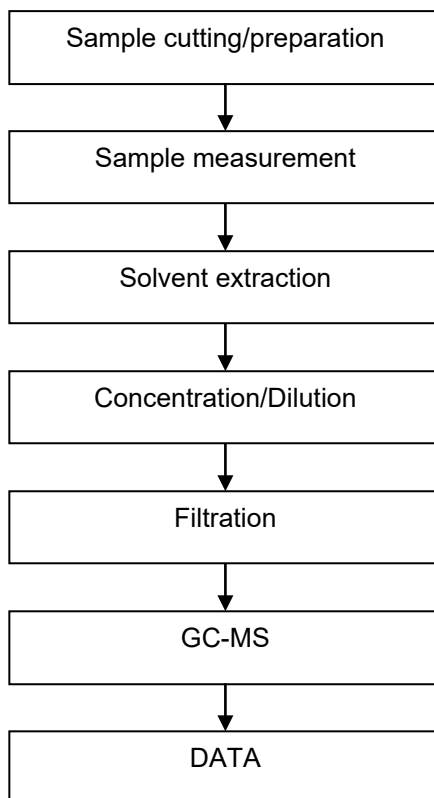

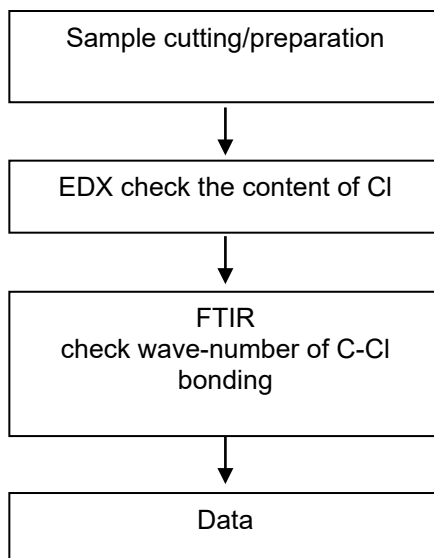

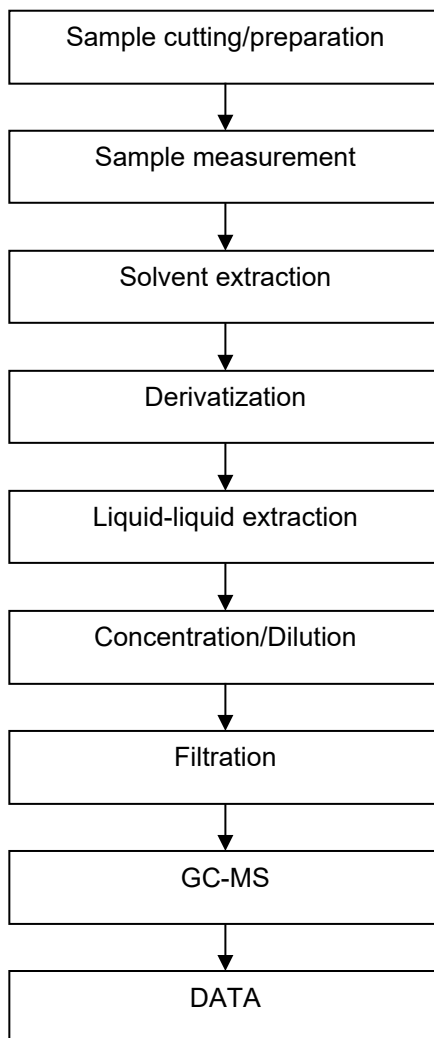

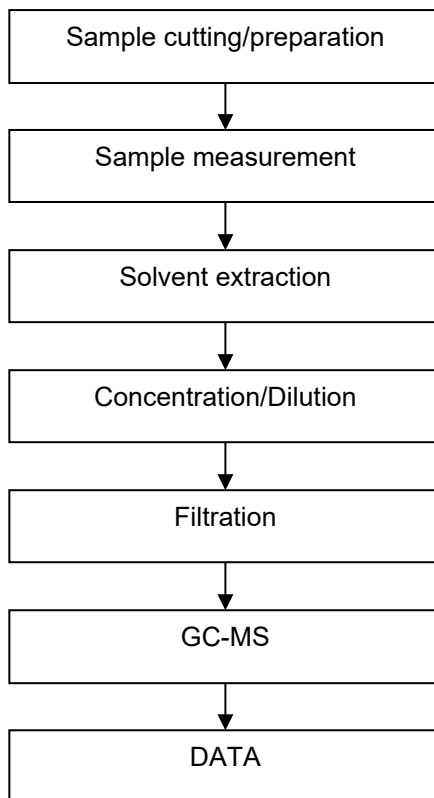

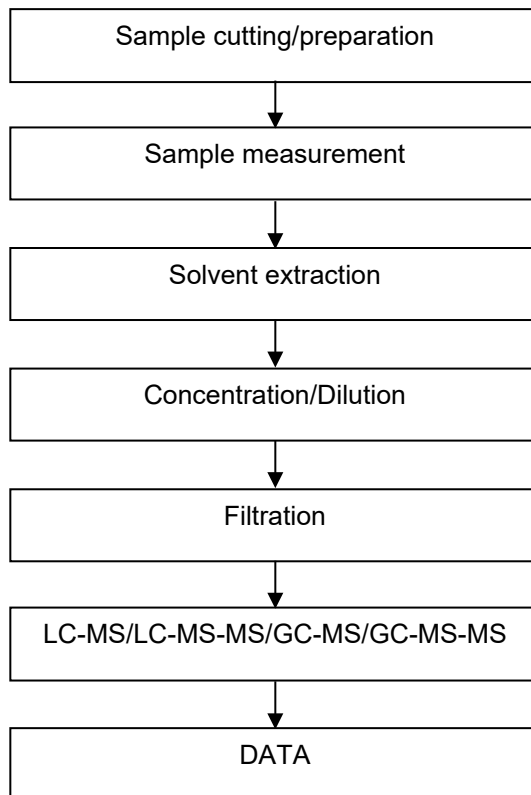

PFASs/ PFOS/PFOA Testing Flow Chart



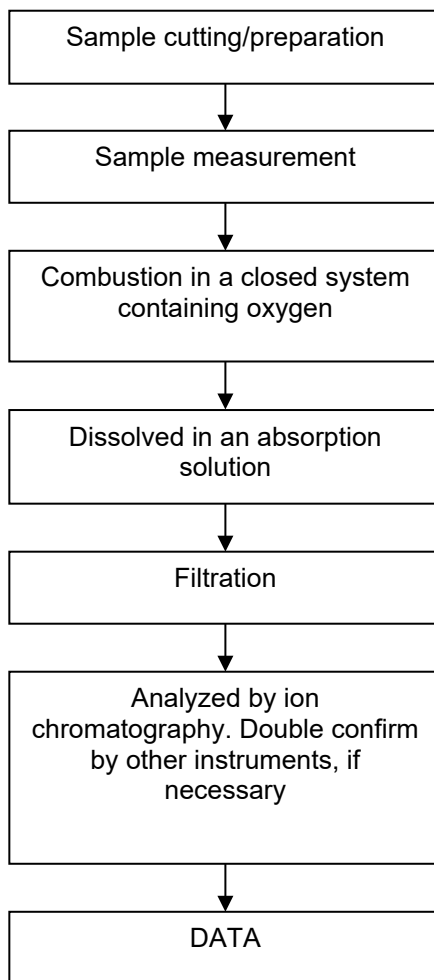

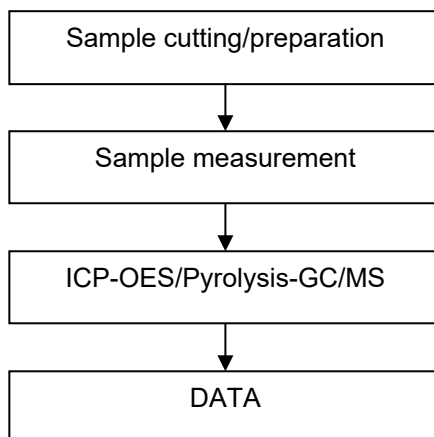
