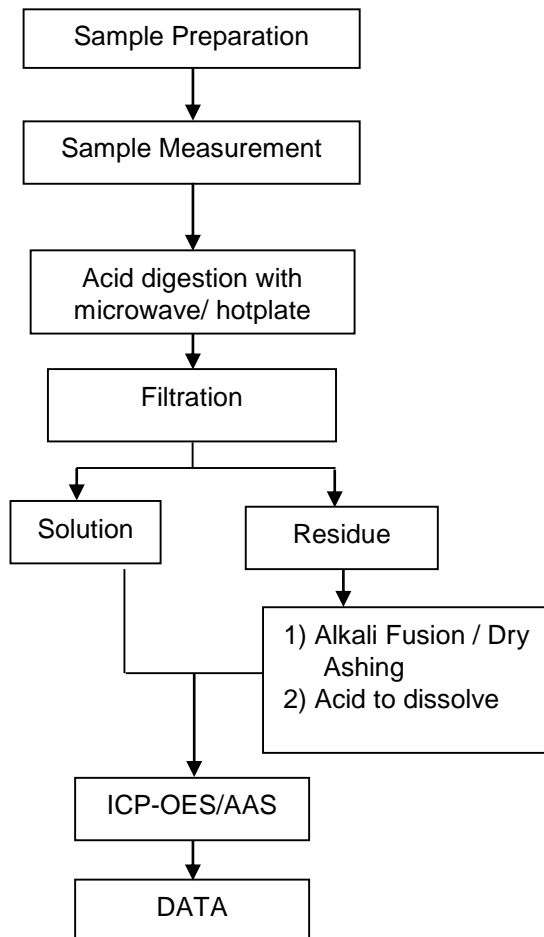

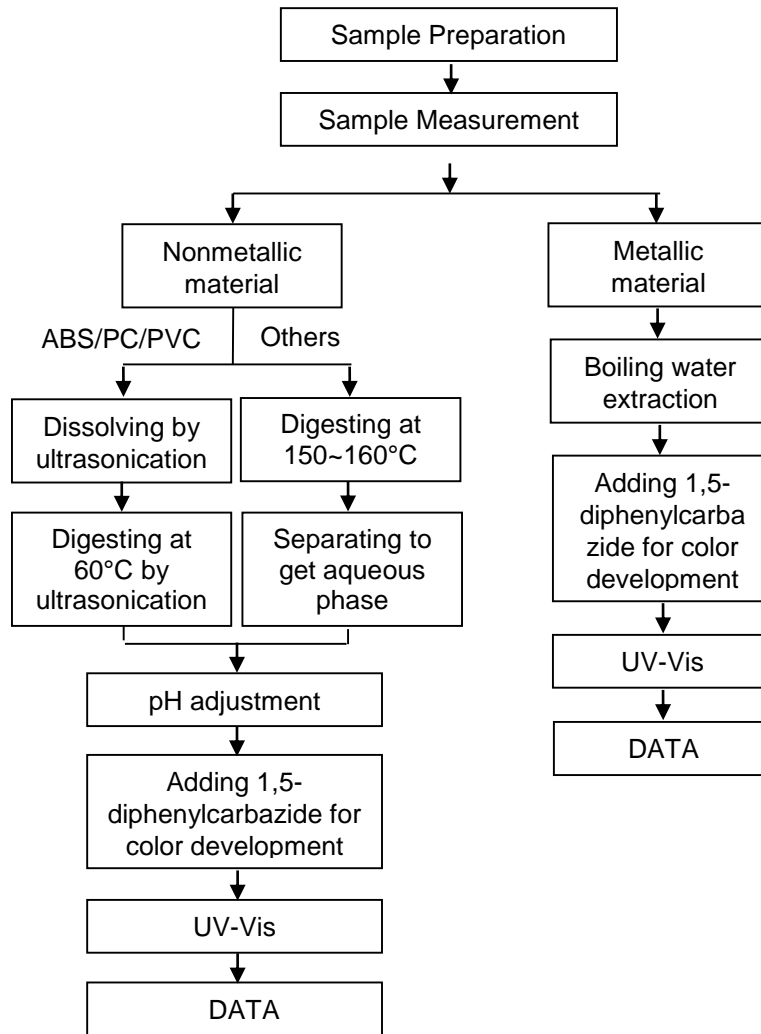

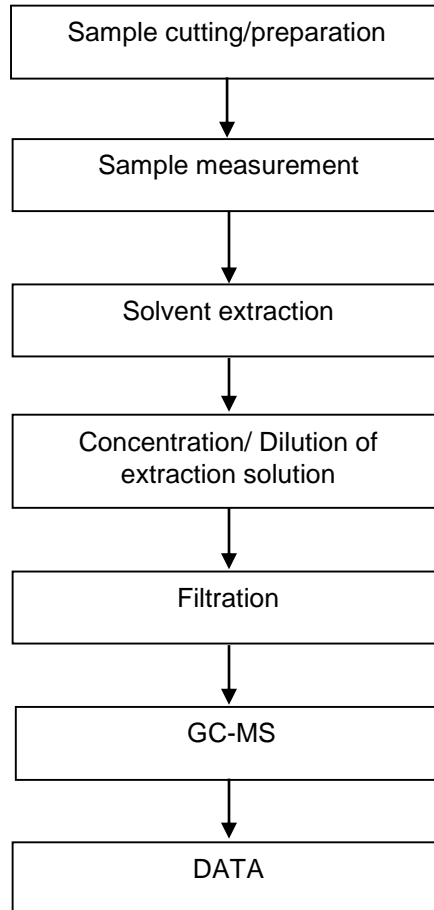
**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**

**PBBs/PBDEs Testing Flow Chart**



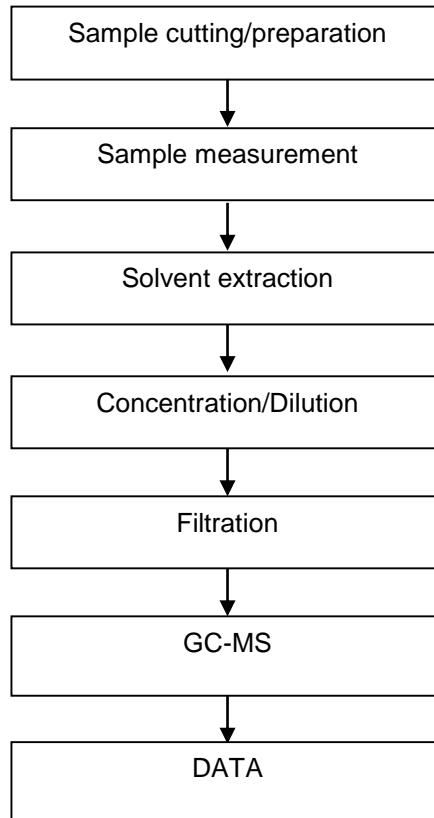

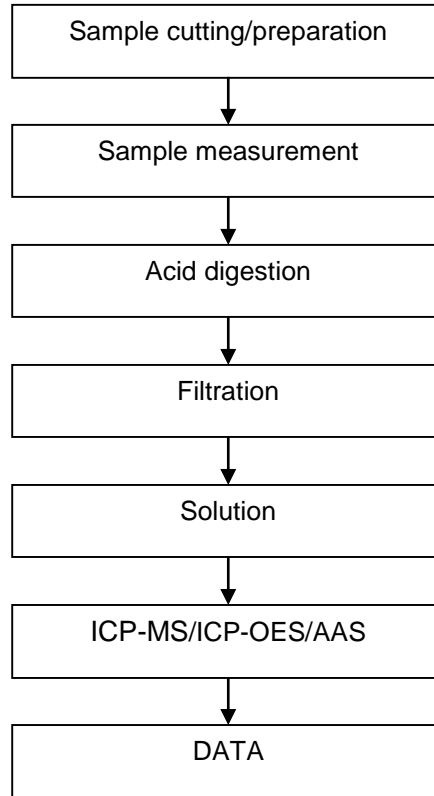

### Elements Testing Flow Chart



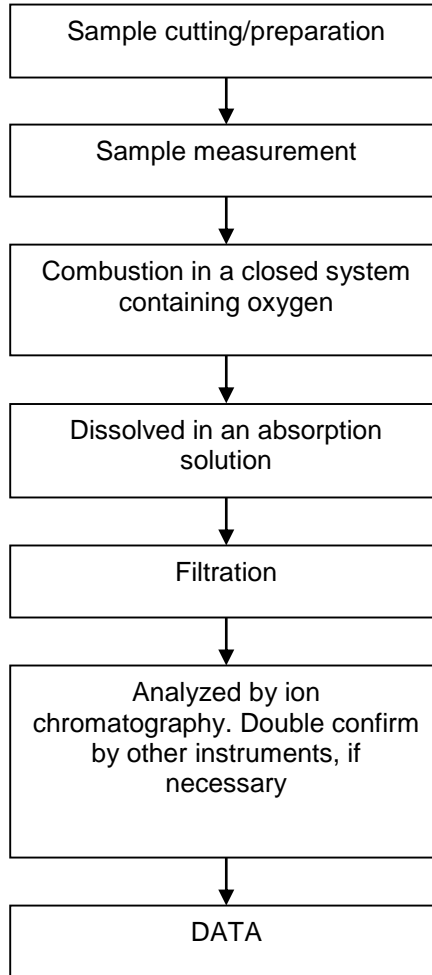

### Halogen Testing Flow Chart



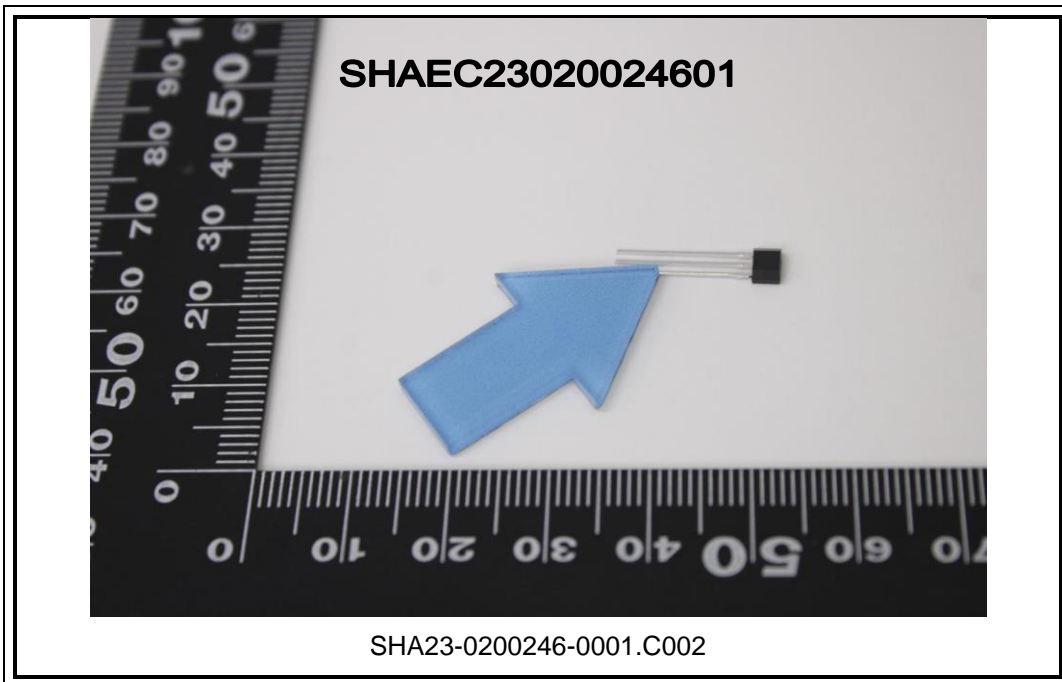
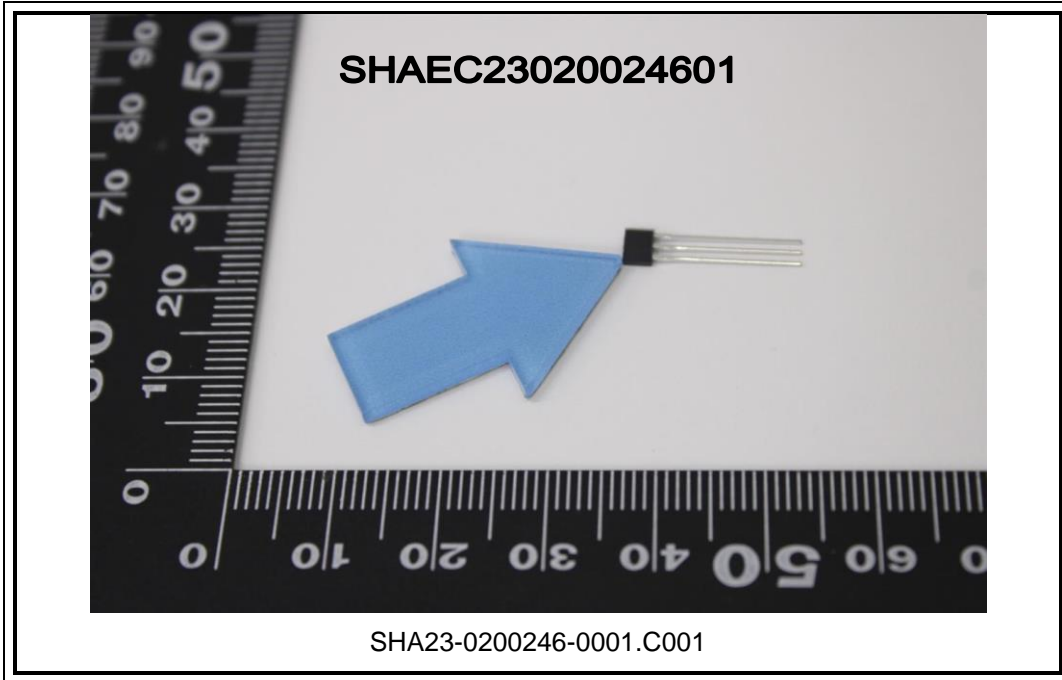
