



### Hexavalent Chromium (Cr(VI)) Testing Flow Chart







#### **PBB/PBDE Testing Flow Chart**







### **Phthalates Testing Flow Chart**





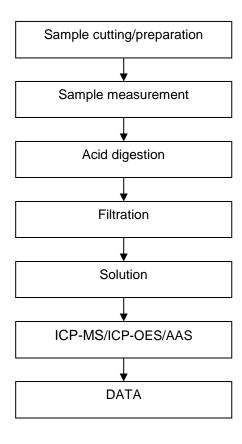



### **Halogen Testing Flow Chart**





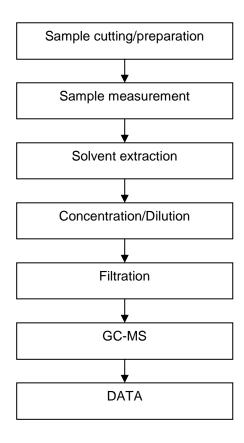

### **HBCDD Testing Flow Chart**






